## **Executive Summary**

This deliverable presents in Section 1 the informed consent procedures that will be implemented before commencement of the relevant research. More specifically, the deliverable outlines in subsection 1.1 the general approach that all MOVING participants will follow during their use case studies, while in subsection 1.2 we provide additional details on the approaches that the University of Manchester (UMAN) and Ernst & Young (EY) will follow. Finally, in the last subsection 1.3 the foreseen contents of the Participants' Information Sheet (PIS) are presented.

In Section 2 a general template Participant Information Sheet (PIS) is presented with all the details that will be provided to all individuals who will participate in the case studies before giving their consent. More specifically, these individuals will be asked to provide MOVING with their informed consent/approval to process personal data. Any data collected for user studies will be strictly anonymous and confidential unless otherwise agreed to by the users of the MOVING community through the informed consent. In all cases, the personal identity of the data subjects will be strictly protected from third parties and will only be used for testing purposes within the project. The consent will fulfil all requirements specified by the data protection law, e.g. it will describe the purpose of the project, types of data that will be collected, responsible data controller etc. Furthermore, the data collected in the project will not be used further for any purpose incompatible with the original purpose of the collection. All rights of the participants, e.g. right to withdraw from a study, right to object, right of access and right to rectify, erase or block will be ensured.

Finally, Section 3 contains some brief concluding remarks, while the Appendix of the deliverable includes the sample PIS that will be used by UMAN, KC and TUD, based on the PIS template presented in Section 2.
